Kare College of Law, Margao Goa in collaboration with the District Legal service Authority, South Goa conducted a Legal Awareness program on Solid Waste Management in G.D. auditorium at G.R. Kare College of Law. The overall aim of the program was to provide legal awareness on the topic Solid Waste Management and to encourage the students to participate in the competitions held to promote reuse and recycling of plastic and to gain knowledge on the same.

- iv)Use of the by-product of composting, using manure as fertilizers and using of gaseous by-products as fuel (biogas).

The camp was conducted under the guidance of the Deputy Chief LADC of the District Legal Services Authority, South Goa, Margao.

The Camp was organised at the Somnath English High School, Savargal, Kirlapal, Dharbandora- Goa on the 27th of June 2024 at 11.00 am. The programme intended to create awareness about Sexual offence against the children belonging to the early adolescent stage, hence the programme was conducted for the students of 8th standard. The programme witnessed a participation of 60 participants.

The commencement was marked by a brief introduction of the organisers by the students and the welcome of the resource persons. Mr. Harshvardhan Gauns Dessai began with the introduction of District Legal Service Authority and the concept of free Legal Aid followed by Miss. Jagruti Samant explaining the definition of Child and shed light on the gender neutrality aspect of the Act. Miss. Diya Vernekar illustrated the meaning and types of Sexual Harassment offences along with Miss. Aastha Gavas who elucidated the finer details of offence of Sexual Assault. Mr. Sidharth Shirodkar decoded the Act with the help of illustrations and threw light upon the punishments. Miss. Jagruti Samant and Mr. Amogh Gavas demonstrated the procedure of 'what to do' and 'whom to report' if the child was to fall victim to any Sexual Offence. The awareness programme concluded with screening of a Short Film on the corresponding topic and distribution of snacks and administrative Kits on behalf of District Legal Service Authority. The students being the resource persons were able to learn the finer details of the POCSO Act and use their knowledge of the legal field to impart accurate knowledge into the young individuals of the society to safeguard them from the evils of concern and were able to construct an interactive environment for learning.
