Measures taken to complete the syllabus of courses and programs. | | <p>The institution invests in a robust broadband connection and provision of computer systems and laptops are also readily available to the faculty members. It has well experienced faculty who ensures the effective use of online resources for ICT enabled teaching- learning such as LCD projectors, audio video facility etc. E-learning resources like Law Journals, legal database, Online Public Access Catalogue (OPAC), access to uninterrupted internet through Wi-Fi and Local Area Network give the Institution an upper edge when it comes to content sharing. Network Attached Storage (NAS) allows faculty to provide a repository of synopsis, outlines of lectures, videos and other study materials made available to the learners. Official communication to the learners is routed through Whatsapp groups monitored by the class mentors, as also through email which provides a paperless mode of regular communication. In addition, the institution maintains its college website and an independent library website to give the best information possible to its learners.</p> <p>Orientation and selection of students for academic activities such as Moot Court, ADR was also done virtually for the first term of the academic year 2021-22. Numerous webinars are conducted by the academic mentors as legal aid cell activities for the purpose of curriculum enrichment. Special lectures such as Master Classes are organized by way of inviting legal luminaries as experts in their respective fields in order to provide guidance on theoretical as well as practical aspects of the academic curriculum in online mode.</p> <p>Examination at both the Internal semester assessment (ISA) as well as s Semester End Assessment (SEA) are conducted in an online mode during the first semester of the academic year. To meet up with any inconsistencies in the online pattern of delivery of curriculum, there is an efficient System Administrator who provides his expertise on the same.</p> <p>In addition the institution in association with the Directorate of Higher Education of the State of Goa and Goa University enables the faculty to generate e-content of teaching modules under the Digital Integrated System for Holistic Teaching and Virtual Orientations (DISHTAVO) which is modelled on Study Webs for Active-Learning for Young Aspiring Minds (SWAYAM) i.e. four quadrant format for Massive Online Open Courses(MOOC). This initiative is beneficial for the students from within the state and outside.</p> <p>Thus the Institution is in a continuous process of striving to further provide a very conducive environment for ICT enabled teaching-learning.</p> | |
