The participants are expected to effectively organize their teams to deal with the issue at hand, establish priorities, and use their skills in a limited time frame to address the challenges.





Guidelines for 4th CCIC

Team composition: one team consisting of three participants from a legal education institution are eligible to register. The participants are required to be registered at graduation or post graduation programme at the institution.

Selection: The applicant teams are required to submit a resume of its members. The organizers reserve the right to select teams.

Language of the Competition shall be strictly in English.

Time: the selected teams will be notified about the time of the events.

Learning sessions shall be on the theme of the competition and are compulsory.

Orientation session is mandatory for participating teams and queries shall be addressed at this session.

Proposition shall be released via registered email only in accordance with requirements of the schedule.

Results shall be declared at the valedictory ceremony and the scores shall be thereafter uploaded on the website of VVM's G. R. Kare College of Law.


