## ***About the Competition***

The Crisis Control International Competition commenced in the year 2022, to offer a fresh approach to legal problem solving, where participants navigate complex, real-world crises in a dynamic and collaborative environment. It is an innovative initiative in the realm of international law, designed to push the boundaries of traditional academic competitions. After completing three successful editions, we are back with the 4th edition with a new theme centered on IPR.

The participants are expected to effectively organize their teams to deal with the issue at hand, establish priorities, and use their skills in a limited time frame to address the challenges.

The participants will engage in this two-day journey, starting with expert-led learning sessions on day one. These sessions equip participants with insights into the area of law as per the year's theme. On the second day, teams are administered with a mock crisis, requiring them to apply their acquired knowledge to prepare their points in a stipulated time allotted to them and present their legal opinions/solutions either in favour or against the proposition.

The ability to accurately analyze situations in the context of International Law and to provide an effective solution shall be assessed based on understanding the issues, application of law, effective arguments, eloquence, and teamwork.

The best team in each category will be declared as the winners.

# ***Guidelines for 4<sup>th</sup> CCIC***

**Team composition:** one team consisting of three participants from a legal education institution are eligible to register. The participants are required to be registered at graduation or post graduation programme at the institution.

**Selection:** The applicant teams are required to submit a resume of its members. The organizers reserve the right to select teams.

**Language of the Competition** shall be strictly in **English**.

**Time:** the selected teams will be notified about the time of the events.

**Learning sessions** shall be on the theme of the competition and are compulsory.

**Orientation session** is mandatory for participating teams and queries shall be addressed at this session.

**Proposition** shall be released via registered email only in accordance with requirements of the schedule.

**Results** shall be declared at the valedictory ceremony and the scores shall be thereafter uploaded on the website of VVM's G. R. Kare College of Law.
