## About **Vidya Vikas Mandal**

The seeds of the Vidya Vikas Mandal (VVM) were sown in the year 1971 by visionaries with a strong sense of social commitment towards the noble cause of education. The founder members of the educational society felt a pulsating need to bring education to the doorsteps of the people of South Goa and cater to their educational needs. This noble step marked the birth of its first institution, the Shree Damodar College of Commerce and Economics in the year 1973.

The year 1979 set another milestone for the VVM which witnessed the birth of the Govind Ramnath Kare College of Law, which was the second Institution under its umbrella. This thoughtful step proved to be a respite to law aspirants and bridged the yawning gap between the need and availability of higher education opportunities for students of South Goa and saved them of the hardships and expenses involved in commuting to the capital city in North Goa and across the country for pursuing their legal education. Higher Secondary School offering Commerce and Vocational streams under the Goa Board of Secondary and Higher Secondary Education; the Vidya Vikas Academy, a school with Higher Secondary Section in the Science stream under the Central Board of Secondary Education (CBSE); the H.M.N. Gaunekar Institute of Management, Training and Research (IMTR) and the Indira Gandhi National Open University (IGNOU) Study Centre.

# BACHELOR OF ARTS & BACHELOR OF LAWS (B.A.LL.B.)

## **ELIGIBILITY FOR ADMISSION TO THE B.A.LL.B PROGRAMME**

**Eligibility for admission to the first year of B.A.LL.B programme is in accordance with Choice-based Credit System as per Goa University Ordinance and DHE directions.**

### **ADMISSION PROCEDURE**

Candidates who are desirous of seeking admission are required to fill in the application form, completed in all respects, along with relevant documents, in accordance with directions provided on the website of the college.

The intake capacity shall be a division of 60, in accordance with the Legal Education Rules, 2008 of the Bar Council of India, inclusive of the State Reservation Policy.

### **ELIGIBILITY FOR ADMISSION TO SECOND YEAR OF B.A. LL.B. PROGRAMME IN ACCORDANCE WITH ORDINANCE OC-34 A.1.3(ii)**

Candidates who are eligible to appear for Semesters I and II shall be eligible for admission to Second Year irrespective of backlogs in Semester I and II.

### **ELIGIBILITY FOR ADMISSION TO THIRD YEAR OF B.A. LL.B PROGRAMME IN ACCORDANCE WITH ORDINANCE OC-34 A.1.3(iii)**

Only those candidates, who have passed Semesters I and II, have fulfilled the requirements of Semesters III and IV and do not have more than FIVE papers as backlog from Semesters III and IV taken together, shall be considered eligible for admission to the Third Year.

### **ELIGIBILITY FOR ADMISSION TO FOURTH YEAR OF B.A. LL.B. PROGRAMME IN ACCORDANCE WITH ORDINANCE OC-34 A.1.3(iv)**

Only those candidates, who have passed Semesters I, II, III and IV, fulfilled the requirements of Semesters V and VI and have not more than FIVE papers as backlog from Semesters V and VI taken together, shall be considered eligible for admission to the Fourth Year.



## **ELIGIBILITY FOR ADMISSION TO FIFTH YEAR OF B.A. LL.B. PROGRAMME IN ACCORDANCE WITH ORDINANCE OC-34 A.1.3(v)**

Only those candidates, who have passed Semesters I, II, III, IV, V and VI examinations, fulfilled the requirements for Semesters VII and VIII and have not more than FIVE papers as backlog in Semesters VII and VIII taken together, shall be considered eligible for admission to the Fifth Year.

Eligibility shall be in accordance with provisions of relevant Ordinance of Goa University mentioned above. Such candidates are required to submit the application form, duly filled in with original mark-sheets of the respective semesters, along with certified copies of the same and will have to compulsorily appear for an interview and counseling in order to complete admission formalities by paying necessary fees.

# MASTER OF LAWS – LL.M.

## **ELIGIBILITY FOR ADMISSION TO THE FIRST YEAR OF LL.M. (CHOICE BASED CREDIT SYSTEM) PROGRAMME IN ACCORDANCE WITH OA-35**

To be eligible for admission to the LL.M. (CBCS) Programme, a candidate shall be required to have obtained a minimum of 50% marks in aggregate (45% in case of SC and ST candidates) at the 5 years or 3 years LL.B. Programme, recognized by the Bar Council of India.

## **DOCUMENTS TO BE SUBMITTED**

1. Birth Certificate or Original S.S.C. / H.S.S.C. Passing Certificate for proof of age (along with self-attested copy).
2. Self-attested copy of Aadhar Card of the candidate.
3. Two copies of passport size coloured photograph of the candidate.
4. Original LL.B. Certificate and statement of marks (along with self-attested copy).
5. Transfer Certificate from the Principal of the college last attended.

In case of students other than from Goa University, Eligibility Certificate and/or Migration Certificate as the case may be, from the Goa University.

## **ADMISSION PROCEDURE**

Admission to the LL.M.(CBCS) Program is based on entrance test GU-ART conducted by Goa University.

Candidates who are desirous of seeking admission are required to fill in the application form, completed in all respects, along with relevant documents, in accordance with directions provided on the website of the College.

The Merit List shall be prepared, based on the highest Rank obtained by the candidate at the GU-ART. The short-listed candidates eligible for admission will have to compulsorily appear before the Committee and exercise choice of specialization, on which basis, the admission will be finalized. Admission formalities will be completed only upon payment of necessary fees.

The intake capacity is a division of 40, in accordance with provisions of the relevant Ordinances.

The Programme shall be based on a system of time-integrated units called Credits, under the Choice Based Credit System (CBCS) and shall comprise Core Courses, Elective Courses (Discipline specific, Research specific and Generic) and Dissertation. The Credits shall be as defined in OA-35.2.3. A student shall be permitted to accumulate, transfer or redeem Credits under the relevant provisions of the Goa University Ordinance relating to Academic Bank of Credits and shall be permitted multiple entry and exit options.

1. A student shall be eligible for the award of a Master's Degree on successful completion of a minimum of 80 Credits.

2. The total number of 80 Credits shall comprise 32 Credits of Core Courses (Compulsory); 32 Credits of Elective Courses; 16 Credits of Dissertation (Compulsory), as specified at OA-35.4.

# PH.D. PROGRAMME FOR DOCTORAL STUDIES IN LAW

## **ELIGIBILITY FOR ADMISSION IN ACCORDANCE WITH ORDINANCE OA – 19A**

### **ADMISSION PROCEDURE**

Candidates who are desirous of seeking admissions to the Ph.D. Programme shall clear an Entrance Examination of the Goa University followed by a personal interview at the Research Centre. However, candidates who have qualified in the examinations of apex bodies such as CSIR-UGC/UGC NET JRF/lectureship, SET/SLET examination of different Indian States/GATE with a valid certificate, or regular M. Phil. Degree holders are exempt from the entrance examination.

Every candidate shall have to compulsorily reside within the territorial jurisdiction of Goa University during the first three years of the period of research leading to the Ph.D. Degree.

### **FEES**

1. Fees are to be paid by the Research Scholar to the Goa University towards registration for the Ph.D. Programme and its continuation. The period of leave/absence shall be allowed in accordance with the relevant Ordinance and/ or Notification, issued by the Goa University from time to time.
2. The Research Scholar shall be required to pay the prescribed annual fee to the College towards the Research Centre, in accordance with the directions issued from time to time.

# GENERAL INSTRUCTIONS

## **INTERNAL ASSESSMENT**

Communications pertaining to all forms of internal assessment through assignments, presentations, tests and /or related activities will be notified from time to time and shall be strictly followed.

## **ELIGIBILITY FOR APPEARANCE AT EXAMINATIONS**

A candidate who has been admitted to the B.A.LL.B./LL.B. Degree programme of the college is required to fulfill the criteria laid down for attendance of lectures/classes/tutorials, including moot-court exercises, mock trial activities, negotiation and mediation sessions, and such other activities in accordance with the Goa University Ordinance OA-17 and Rule 12 of the Legal Education Rules, 2008 of the Bar Council of India. Failure to fulfill the requirements laid down in the above mentioned Rules will be treated as ineligible to appear at the examination and an unsuccessful completion of the semester/term.

A candidate who has been admitted to the LL.M. (Choice Based Credit System) programme of the college is required to fulfill the criteria laid down for attendance of lectures/ classes/ tutorials in accordance with the Goa University Ordinance OA-17. Failure to fulfill the requirements laid down in the above mentioned Rules will be treated as ineligible to appear at the examination and an unsuccessful completion of the semester/term.

## **CHOICE OF SPECIALISATION AND/OR OPTIONAL COURSES/SUBJECTS**

A student has to compulsorily exercise in the application form, the choice of specialization and/or optional courses/subjects, if any, for the respective semesters, in the beginning of the Academic year and appear before the Admission Committee. The college will offer specialization and/or optional course/subjects, only in case the requisite number of students for a particular specialization and/or optional courses/subjects is enrolled.

## **DURATION FOR COMPLETION OF A PROGRAMME**

The total duration available for a student to complete any programme is twice the actual duration prescribed for the respective programme. Rules for completion of the programme are in accordance with the Goa University Ordinance OA-16.11.

## DEPARTMENT OF LIBRARY & INFORMATION SCIENCE

Library plays the vital role in enhancing the quality of academic environment in educational Institution in particularly law institution. The Library is well equipped and has a collection of approximately 21,628 bar-coded books including an exclusive rare collection of about 50 books and with subscription to vital law reports, 30 periodicals and 11 newspapers.

The Reading room is well furnished and can accommodate 60 students. In addition, the Library has a Discussion Room and a Research Centre with a capacity for 20 students each. The Library also has study carrels to make individual studying conducive. Library is also equipped with desktop computers, laptops, and Kindle which are used by the students to pursue academic excellence. CCTV cameras are installed for proper surveillance.

Library is automated with the KOHA open-source integrated library system. OPAC (Online Public Access Catalogue) is provided through college computer network and students can access bibliographic details of the books available in the library. The library also has a subscription to Digilegal database wherein students have an access to the old and latest judgments of the Supreme Court of India and all other High Courts of India, including Bare Acts and Notifications. An offline access is available to All India Reporter. The Library has the Database of ILI Law Journals Article Since its inception (i.e. 1965 till 2010) and Annual Law Reports from (1965 to 2010). Each student has an access to e-journals, e-books with separate user ids and passwords through a subscription to N-List.

The Library has caliber e-book management software wherein about 800 public domain law books are made available to the students. It is a repository of dissertations, question banks and of articles published by college faculty.

It has a Book Bank Scheme in which books are issued for every course/subject to all the bonafide students in addition to the books issued by the library otherwise, for each semester till the end of examination of the respective semester. The Library's exclusive website i.e. [www.grkarelawlibrary.yolasite.com](http://www.grkarelawlibrary.yolasite.com) contains all latest and updated details of the college along with other relevant information such as syllabus, question papers, links to the free legal sources for the students, and so on Library also has a facility of photocopying machine wherein students are allowed to take print, photocopy or scan books or other relevant documents.

4. Use of mobile phones is strictly prohibited in the classrooms and library and will be governed by the Rules relating to phones in this regard.
5. Possession and/or consumption of alcohol and/or drugs is strictly prohibited and subject to strict disciplinary action as decided by the Disciplinary Committee.
6. All students shall wear the Identity Card at all times while in the college campus.
7. Entry of motor vehicles in the campus wherein drivers/ riders do not possess valid driving/ riding licence is prohibited. In case of motorcycles, use of helmet is compulsory
8. Any inappropriate/violent behavior in the campus is subject to strict disciplinary action.

### **INFORMATION AS TO FEES**

The annual tuition fee is fixed with the approval of Goa University and the Government. If there are any changes in the fee structure, the students will be required to pay such fees accordingly. Changes in fee structure, if any, will be informed /notified as per University Fee Structure Committee guidelines. Students applying for a Transfer Certificate from the college should have cleared all dues. A student applying for a Transfer Certificate shall pay the prescribed fees for the same. Fees payable for each semester examination is notified by the University from time to time and is payable accordingly. Migration Certificate is required to be produced compulsorily by the student of other universities. A student who wishes to cancel his/her admission will be eligible for refund of fees as per the rules laid down by the Goa University and notified from time to time.
