Chief guest for the lecture was Sr. Adv. Devidas Pangam, Advocate General, Goa. The topic of the lecture was 'Insights on the Bare Act of CPC: How to demystify the technical language of a bare Act'.

The objective of the Guest Lecture was to provide students with comprehension of the bare Act of CPC as they graduate as Lawyers. The compere of the program Ms. Mariam George, student of Second Year BALLB, welcomed the gathering.

Mr. Nitin Kunkolienkar, President of VVM and Chairman Governing Council delivered an opening remark, highlighting the importance and relevance of the topic.

Various doctrines such as the Doctrine of Res Judicata and Sub Judice were also discussed citing illustrations and case laws.
