

Visit to Central Jail, Colvale

The Criminal Law Club of G.R. Kare College of Law, Margao, conducted a visit to the Central Jail, Colvale, on the 6th, 8th, 9th and 11th of January 2025. The visit was organized so that the students gain practical exposure to the operations of the correctional system and the legal processes involved in confinement and the rehabilitation of the offenders, additionally, the students were provided real-world insights into criminal law.

The students of the Third Year LL.B. Degree Programme and the Fourth Year B.A.LL.B. Programme visited the Central Jail, Colvale, on seeking the permission for the same from the Inspector General of Prison, Panjim. The visit was divided in 4 batches of students comprising of 103 students, they were accompanied by 6 faculty members.

On the 6th of January 2025, 28 students of the Third Year LL.B. Degree were scheduled for the visit. The students were accompanied by Ms. Ruby Z. Luis, Asst. Professor GRKCL and incharge of the Criminal Law Club and Ms. Afshan Bi, Asst. Professor GRKCL.

The second visit was conducted on the 8th of January, 2025, 25 students of the Third Year L.L.B Degree were accompanied by Ms. Ruby Z. Luis, Asst. Professor GRKCL and incharge of the Criminal Law Club and Ms. Yamini J. Dalvi, Asst. Professor GRKCL.

The third visit was conducted on the 9th January, 2025 where 24 students of the Fourth year B.A.LL.B. were accompanied by Ms. Afshan Bi, Asst. Professor GRKCL and Ms. Aditi Narvekar, Asst. Professor GRKCL.

The fourth visit was on the 11th of January, 2025 comprising of 23 students they were accompanied by Mr. Harshad Bandodkar, Asst. Professor GRKCL and Ms. Afshan Bi, Asst. Professor GRKCL.

On each of the days, upon completion of all formalities, the students were taken to the jail premises by Mr. Paresh Gauns Dessai, Asst. Jailor and Mr. Lotlikar, Asst. Jailor, to have an insight of the Prison Premises. The students were given the privilege to visit all the blocks in which the inmates were present. The visit included the hospital housed within the jail, legal aid center, library which comprised of various books pertaining to literature, history and science, IGNOU study center, recreation room, music room, kitchen block, workshop or factory block which consisted of carpentry, tailoring, candle making, paper bag making, idol making etc., solitary confinement block, block for under-trials, block for NDPS-under trials and a separate block for women convicts.

All the blocks were well maintained. A separate block is created for the purpose of video conferencing, the students were lucky to have witnessed the process of recording evidence of various inmates. During all the visit the students experienced the influence of reformative form of punishment. The Prison Authorities took up all the queries raised by the students. The visit was very informative and the students learned a lot about prison administration.

Nyaya Yatra-Journey to Justice

The Nyaya Yatra-Journey to Justice, is an innovative concept started by G.R.Kare College of Law, Margao, in collaboration with the South Goa District Legal Services Authority and Konkan Railway Corporation. The Nyaya Yatra was launched at the Konkan Railway Station, Margao, on Friday, the 17 th of January, 2025 at 9.30 am. Adv. Sangram Desai, Chairman, Bar Council of Maharashtra and Goa, Adv. Pravin Faldessai Deputy Solicitor General of India, Ms. Sarika Faldessai, Judicial Officer and Secretary of the District Legal Services Authority graced the occasion with their presence. The legal aid volunteers of G. R. Kare College of Law presented a skit at the entrance of the Margao railway station highlighting the duties and rights of the citizens traveling in trains. It was followed by the invocation song and lighting of the lamp. It is our duty to ensure that person from the last strata of life should get justice, said Adv. Sangram Desai, Chairman, Bar Council of Maharashtra and Goa, after launching the Nyaya Yatra.

Further on he said that citizens should be conscience about performing their constitutional duties and he opined that if everyone performs their duties, we need not emphasize on rights. He said that the Bar Council of Maharashtra and Goa was eager to be part of any legal awareness campaign and called upon the law students to get associated with the Bar Council in creating a legally informed society.

Vidnyan Dhara Series Session 2025



VVM's G.R.Kare College of Law, Margao organized a session under Vidnyan Dhara series 2025 which was conducted on 20th January 2025. The resource person for the session was Dr. Ramesh Chatragadda, Senior Scientist, CSIR-National Institute of Oceanography, Donapula , Goa.

Dr. Ramesh delivered lecture on the topic "Exploration of Ocean's Gifts to Human Well-being". During his lecture he delved into the profound impact oceans have on the planet and overall health and prosperity of humanity. He offered a comprehensive look into how oceans contribute to the well-being of people around the world, touching on ecological, economic, and health-related aspects. He discussed the ecological importance of ocean and stressed upon the need for healthy oceans for mitigating effects of climate change. The lecture explored the diverse resources oceans provide, including food supply, medicinal benefits and economic benefits.

The resource person highlighted the significance of certain marine organisms such as corals, coral reefs, crustaceans etc.and explained their unique qualities which can be tapped by human beings for their well being. He also focused on link between ocean health and human health. He informed that Oceans are under threat due to plastic waste, chemicals, and overfishing. These pose direct harm to marine organisms and eventually to human health. He urged the students to study law of sea and laws related to the marine life and biodiversity so as to make a difference in the field of oceans and protection of marine biodiversity. He successfully answered the questions posed by the students. The session was coordinated by Dr, Shruti Nadkarni, Assistant Professor & HoD and Institue Co-ordinator for Vidnyan Dhara Series.

Report on the Youth Constituent Assembly Dialogue for change: Vision 2047



The VVM Govind Ramnath Kare College of Law, in association with the Directorate of Higher Education (DHE), organized the Youth Constituent Assembly Dialogue for Change on the topic "Vision 2047". The event aimed to provide a opportunity for students to critically engage with the Indian Constitution and think about its role in shaping India's future.

The event commenced with the lighting of the lamp. The Principal of the college welcomed the guest and narrated the institution's journey. The Chief Guest for the event, Mr. Bhushan Savaikar, Director of DHE and an alumnus of the college, was introduced by Ms. Merville Rodrigues. Mr. Savaikar's illustrious career includes serving as Joint Secretary to the Chief Minister and as a Mamlatdar for over a decade.

Mr. Sapresh Devidas, the coordinator of the event, shared the inspiration behind the initiative. Drawing from a statement by the Prime Minister emphasizing the importance of students understanding the Constitution, he conceptualized the theme "Drafting a Vision for 2047". He highlighted the four topics for the event: Rights, Government, Innovation, and Sustainable Development.

In his address, Mr. Bhushan Savaikar emphasized the importance of having in-depth knowledge of subjects and practical application of constitutional principles. Reflecting on his own academic journey, he urged students to adopt a comprehensive approach towards learning. He also stressed the need to prioritize the "happy index" and sustainable development for a better future.

Dr. Pradeep Sarmokadam, the second speaker, threw light on pre- and post-independence India and discussed the challenges of living by the Constitution . He encouraged students to critically analyse constitutional provisions and adapt them to modern-day challenges. He also emphasized the importance of biodiversity, environmental conservation, and sustainable practices, referencing Articles 48A and 51G of the Constitution.

The inaugural ceremony concluded with a vote of thanks by Ms. Yamini Dalvi.

Sessions by Experts

Session 1: By Dr. Pradeep Sarmokadam

Dr. Sarmokadam, an expert in environmental planning, spoke on the Biodiversity Act, 1992, and its relevance in addressing biodiversity loss and technological advancements. He emphasized the need for sustainable and equitable development and also mentioned of Goa's efforts in documenting flora and fauna. Highlighting the balance between economic development and sustainability, he stressed the importance of environmental conservation as a collective responsibility.

Session 2: By Dr. Venugopal Rao

Dr. Rao brought a global perspective with his impressive academic credentials. He discussed the implications of artificial intelligence, digital technology, and social media on constitutional amendments. He raised questions about the intersection of technology and rights, including concerns about privacy (Article 21) and the challenges posed by automation and humanoids in the job market. He emphasized the need for proactive measures to address these emerging issues.

Session 3: By Mr. Abhishek Mishra

Mr. Mishra's session focused on decolonization of the legal system. He traced the evolution of India's constitutional framework from colonial influences to its current form. Highlighting India's unique cultural and historical context, he encouraged students to draw inspiration from India's rich heritage while shaping the Constitution's future. His insights on the significance of Indian knowledge systems and their integration into contemporary legal frameworks resonated deeply with the audience.

This was followed by Student Presentations and Judging where students from various colleges presented their drafts on the Constitution, exploring themes such as:

- 1. Rights: Topics included digital privacy, environmental rights, gender equality, and human rights education.
- 2. Innovation in the Constitution: Addressed digitalization, the use of AI in governance, and technological advancements to reduce case backlogs.
- 3. Sustainable Development: Focused on conservation, economic sustainability, and renewable resources.
- 4. Privacy and Justice: Highlighted the importance of cybersecurity and balancing privacy with justice.

The presentations were evaluated by esteemed judges, Advocate Yatish Naik and Ms.Twiggy Fernandes , who commended the students for their critical insights and innovative approaches.
