**MANDATORY REQUIREMENTS:**

- (i) Certificate stating 15 years residence of the candidate in Goa, issued by the State Government.
- (ii) Knowledge of Konkani is essential and knowledge of Marathi is desirable.

**ESSENTIAL QUALIFICATIONS:**

- (i) A Master's degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- (ii) Clearance at the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SET. However, candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022, as incorporated in the relevant Goa University Statutes, shall be exempt from the requirement of the minimum eligibility condition of NET/SET for appointment.

**Note:**

- A. Applicants not fulfilling MANDATORY REQUIREMENTS, need not apply.
- B. In the event of non-availability of candidates fulfilling ESSENTIAL QUALIFICATIONS, i.e. possessing NET/SET etc., candidates fulfilling ESSENTIAL QUALIFICATIONS may be considered for appointment.
- C. Complete hard copy of applications in all respects including e-mail ID along with self-attested photostat copies of statement of marks and passing certificates of all public examinations from SSC onwards, including valid Certificates will have to be produced (self-attested & original), on the day of the walk-in interview scheduled to be held on Friday, 26<sup>th</sup> June, 2026 at 9.30 am in the college premises.
